1. **Bhumikasthan Municipality** towards the cost of Procurement and Supply of Plastic Tunnel and intends to apply part of the funds to cover eligible payments under the Contract for Procurement and Supply of Plastic Tunnel. Bidding is open to all eligible Nepalese Bidders.
2. **Bhumikasthan Municipality, Nuwakot, Arghakhanchi** invites sealed or electronic bids from eligible bidders for the procurement of Plastic Tunnel under *National competitive bidding procedures specified in Public Procurement Act and Regulations*.

Or Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.holpatra.gov.np/epp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below and

5. Pre-bid meeting shall be held at **Bhumikasthan Municipality**, office of the Municipal Executive Nuwakot, Arghakhanchi at 1:00 pm on **2077/11/25 (7th Feb, 2021)**
6. Sealed or electronic bids must be submitted to the office of **Bhumikasthan Municipality, Nuwakot, Arghakhanchi** by hand/courier or through PPMO's e-GP system www.holpatra.gov.np/epp on or before 12:00 Noon on **2077/11/06 (18th Feb, 2021)**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 pm on **2077/11/06 (18th Feb, 2021)** at the office of **Bhumikasthan Municipality, Nuwakot, Arghakhanchi**. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **71,000**, which shall be valid for 30 days beyond the validity period of the bid.
