Invitation for Bids for the **Nuwakot Khilji Asurkot Moterable Raod Blacktop and Structural Work.**

1. The Government of Nepal [GoN] has allocated funds towards the cost of Nuwakot Khilji Asurkot Moterable Raod Blacktop and structural Work. and intends to apply part of the funds to cover eligible payments under the Contract for Nuwakot Khilji Asurkot Moterable Raod Blacktop and structural Work. (Contract No: 46/BMA/W/BT/078/79). Bidding is open to all eligible bidders as per Section V of Bidding Document.
2. Bhumikasthan Municipality invites electronic bids from eligible bidders for the construction of Nuwakot Khilji Asurkot Moterable Raod Blacktop and structural Work. under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
  - **Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years:** NRs.39900000
  - **Minimum Work experience of similar size and nature:** NRs.21975000.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate Electronic BID, one containing (i) the Technical Bid and the other (ii) the Price Bid.
4. Eligible Bidders may obtain further information and inspect the Bidding information at the office of Bhumikasthan Municipality, Arghakhanchi, Lumbini Province, Nepal or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).

A complete set of Bidding Documents may download from PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) by eligible Bidders upon payment of a non-refundable fee of 5000.0 NRs. till 11-03-2022 17:00 PM during office hours. Bidder who chooses to submit their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below

6. Pre-bid meeting shall be held at Bhumikasthan Municipality, Arghakhanchi Lumbini Province, Nepal at 01-03-2022 13:00 hours

Electronic bids must be submitted to the office Bhumikasthan Municipality, Arghakhanchi, Arghakhanchi, Lumbini Province, Nepal through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 13-03-2022 12:00. Hrs. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13-03-2022 13:00 hours at the office of Bhumikasthan Municipality, Arghakhanchi Lumbini Province, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the **bid security** in pdf format in case of e-bid, amounting to a minimum of **NRs. 776000** which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
